### **Takeda Announces Issuance of Unsecured Euro Denominated Senior Notes**

**Osaka, Japan, November 8, 2018** --- Takeda Pharmaceutical Company Limited (TSE: 4502) (the “**Company**” or “**Takeda**”) announces that it has today launched the offering of its unsecured euro (“**EUR**”) denominated senior notes (the “**Notes**”).

The Notes will be issued to investors to finance a portion of the funds necessary for the acquisition of Shire plc (the “**Acquisition**”) and reduce commitments under the 364-Day Bridge Credit Agreement entered into in connection with the Acquisition on May 8, 2018 (as amended on June 8, 2018 and October 26, 2018). A description of the Notes is set out below.

In accordance with Rule 26 of the City Code on Takeovers and Mergers, a copy of the preliminary offering circular in respect of the Notes will be available to view on Takeda’s website at [www.takeda.com/investors/offer-for-shire](http://www.takeda.com/investors/offer-for-shire) by no later than 12 noon (London time) on the business day following the publication thereof. Please note that the Acquisition remains subject to certain conditions, including receipt of the remaining regulatory clearances and approval by the shareholders of both companies.

#### **Description of the Notes**

(a) Types of Notes	Unsecured EUR Denominated Senior Notes
(b) Maturity	Unsecured EUR Denominated Senior Notes due 2020, 2022, 2026 and 2030
(c) Offering Method	Private offering in foreign markets including the U.S., Europe and Asia. The Notes will not be offered or sold within the U.S. or to U.S. persons, except to “qualified institutional buyers” in reliance on the exemption from registration provided by Rule 144A under the U.S. Securities Act of 1933, as amended (the “ <b>Securities Act</b> ”).

An Opening Position Disclosure must contain details of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s). An Opening Position Disclosure by a person to whom Rule 8.3(a) applies must be made by no later than 3.30 pm (London time) on the 10th business day following the commencement of the offer period and, if appropriate, by no later than 3.30 pm (London time) on the 10th business day following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.

Under Rule 8.3(b) of the Code, any person who is, or becomes, interested in 1% or more of any class of relevant securities of the offeree company or of any securities exchange offeror must make a Dealing Disclosure if the person deals in any relevant securities of the offeree company or of any securities exchange offeror. A Dealing Disclosure must contain details of the dealing concerned and of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s), save to the extent that these details have previously been disclosed under Rule 8. A Dealing Disclosure by a person to whom Rule 8.3(b) applies must be made by no later than 3.30 pm (London time) on the business day following the date of the relevant dealing.

If two or more persons act together pursuant to an agreement or understanding, whether formal or informal,

to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3.
